**FIRST AMENDMENT TO  
DECLARATION OF HARBOUR PARK CONDOMINIUMS**

THIS FIRST AMENDMENT TO THE DECLARATION OF HARBOUR PARK CONDOMINIUMS made this 15<sup>th</sup> day of March, 2001, by SLK Developers, Inc. (hereinafter "Declarant"),

WITNESSETH:

WHEREAS, the original Declaration of Harbour Park Condominiums was declared on September 17, 1999, by the Declarant herein and filed for recordation on September 24, 1999, in Book 10782, at pages 201 through 262 of the Mecklenburg Public Registry (hereinafter the "Declaration"); and

WHEREAS, Section 2.1 of the Declaration specifically provides that a Unit may be subdivided into two or more Units pursuant to Section 47C-2-113 of the Condominium Act; and

WHEREAS, North Carolina General Statute Section 47C-2-113 of the North Carolina Condominium Act specifically permits a unit to be subdivided into two or more units if the Declaration expressly so permits; and

WHEREAS, Declarant is the owner of Condominium Unit E, Building 1, in Harbour Park Condominiums as described in the Declaration of Harbour Park Condominiums recorded in the Office of the Register of Deeds for Mecklenburg County, North Carolina in Book 10782, at page 201, and more particularly described in Plans and Surveys (the "Plans"), filed for record in Condominium Unit Ownership File No. 506 in said Office of the Register of Deeds for Mecklenburg County, North Carolina, which Declaration and Plans are incorporated herein by reference; and

WHEREAS, Declarant desires to subdivide said Condominium Unit E, Building 1, into two condominium units.

NOW, THEREFORE, pursuant to Section 47C-2-113 of the North Carolina Condominium Act and Section 2.1 of the Declaration, the Declaration is hereby amended as follows:

1. Section 2.1 of the Declaration is hereby amended to provide that the Condominium shall contain twelve (12) Units rather than eleven (11) Units.
2. The new Unit created shall be Condominium Unit G, Building 1, in Harbour Park Condominiums as described in the Declaration of Harbour Park Condominiums (the Declaration) as recorded in the Office of the Register of Deeds for Mecklenburg County, North Carolina, in

Book 10782, at page 201, and as amended herein, and more particularly described in the Plans and Surveys (the Plans) filed for record in Condominium Unit Ownership File No. 506 in said Office of the Register of Deeds for Mecklenburg County, North Carolina, as revised on March 14, 2001, in Unit File No. 506, page 9.

3. Exhibit "C" to the Declaration, entitled "Table of Interest", shall be amended such that Unit E, Building 1 has been subdivided into Unit E, Building 1 and Unit G, Building 1, and the Table of Interests shall be amended as follows:

Except as expressly amended herein, in all other respects the original Declaration of Harbour Park Condominiums shall remain unchanged and is hereby approved, ratified and affirmed.

IN WITNESS WHEREOF, the Declarant, who is also the Owner of Condominium Unit E, Building 1, of Harbour Park Condominiums, has caused this First Amendment to the Declaration to be executed this 15th day of March, 2001.

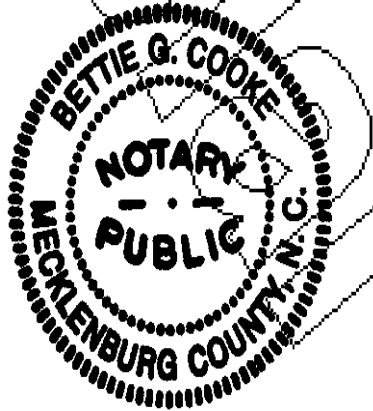

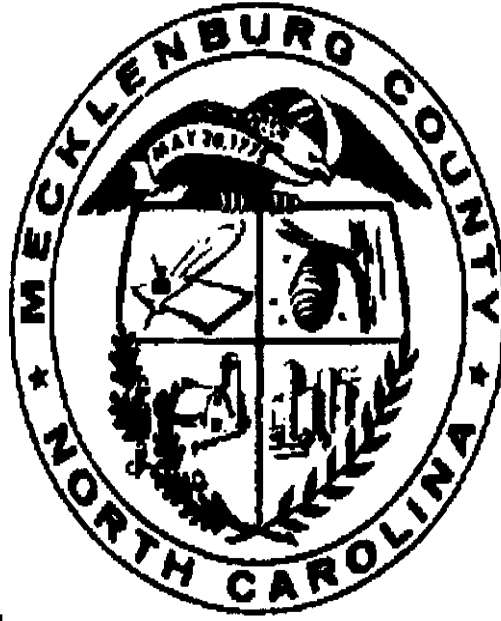
